 - c. obey instructions from any Club instructors, their assistants, and officials; and
 - d. provide the Club with the Waiver and Indemnity in Part 3.

5. Initial applicants for membership, if approved, have the status of provisional members of the Club and are required to pay Club subscriptions and training fees. Provisional members are subject to further approval by the Committee in order to become members, and membership is not automatically guaranteed.

6. Other applicants may be renewing members and visitors who are required to pay Club subscriptions and training and other fees or be paid remuneration as appropriate.

- The Club as used in this part includes any of its officers, committee members including its Executive and Patron, members in any category, visitors, instructors or their assistants, founding members, and anyone who assists the former in the conduct of Club activities including the supplier of any venue;
- “I”, “me” and “my” as used in this part means “myself” and extends to include my child as appropriate; and
- “We”, “us” and “our” as used in this part means “the Club and I”.

Waiver and Indemnity:

Accepting the foregoing in this Part and in consideration of my participating in the Club to learn practise and instruct Karate / Kobujutsu and engage in other activities, so far as is lawfully permitted and with effect from the date of signing of this Form for the period, **in applying to become a Member or Visitor of the Club**, I acknowledge there are inherent and obvious risks and dangers in my participation in Karate/ Kobujutsu training that can result in loss and injury and I therefore waive any and all claims for liability

against the Club.

I duly agree to release and indemnify the Club, its instructors, officials and associated International Karate Do Goju Kai Association (IKGA) from any and all claims, liability for injury, loss or damage, however caused, arising out of or associated with my participation in any of the Club's training in Karate / Kobujutsu or its other activities.

We agree that this Waiver and Indemnity may be pleaded as a full and complete bar to any action, suit or proceeding commenced now or taken at any time by or on behalf of me with respect to or in any way connected with the conduct of the Club's activities.

It is further agreed that we will have recourse only to the law and courts of NSW in any matter of ours in which either of us is entitled to plead this Waiver and Indemnity.
